8. **Rebates checks will be issued and sent directly to the End User.** If a customer, such as an education or state entity, is unable to accept rebate checks directly from Polycom, a check may be issued to the reseller. In this case, the reason must be documented on the Claim Form and authorized by the End-User customer. The reseller must provide the **rebate in advance to the End User customer.** The **reseller invoice must include a line item deduction off the total invoice amount** for the full rebate amount to validate the up front rebate was given.
